- 14. There shall not be any financial commitment either to this University or to the Government.
- 15. Hostel accommodation shall be made available for the students.
- 16. Required furniture shall be provided wherever necessary.
- 17. Furnishing of false information to the University on any matter of suppression of facts while furnishing information to the University or violation of any of the Statutes, Ordinances, regulations, Rules, Instructions of conditions of affiliation shall result in withdrawal of the affiliation of the course.
- 18. During the University Examinations, the question paper will be sent through internet for which the following equipments have to be purchased and kept ready by the institution,

ANNEXURE

The Provisional Affiliation is granted subject to the following conditions.

- 1. The number of seats will be reviewed every year and the performance will be taken into consideration for increasing the number of seats.
- 2. For the courses for which Ambulances are necessary the Hospitals should have proper Registration Certificates.
- 3. For tie-up with other Hospitals necessary documentary evidences to be provided.
- 4. An undertaking should be given by the concerned Hospital or Institution in a Stamp paper value of Rs.20/- stating that after getting Provisional Affiliation from this University, the concerned courses should be conducted under this University only. If they have already admitted candidates under any other University, those candidates will complete the courses under the particular University.
- 5. The candidates should be admitted before the cut off date (ie.) **30 .09 .2018** and they will be registered to take up their Examination as per existing regulations.
- 6. There shall not be any admission after the cut off date.
- 7. The Institution/Hospital should undertake to abide by the provisions of the Tamil Nadu Dr.M.G.R. Medical University, Chennai, Act 1987 (Tamil Nadu Act, 37 of 1987) and by the Statutes, Ordinances, Regulations and Rules of the Tamil Nadu Dr.M.G.R. Medical University applicable to the Allied Health Course framed from time to time.
- 8. The Institution/Hospital should agree for Inspection by the Tamil Nadu Dr.M.G.R. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for Allied Health Course framed from time to time.
- 9. They should abide by the Statutes, Ordinances, regulations and Rules framed by the Tamil Nadu Dr.M.G.R. Medical University on matters of Syllabus, Examinations, Code of conduct, extracurricular activities, etc. from time to time.
- 10. Only qualified staff shall be appointed to handle the classes. No unqualified staff shall be appointed.
- 11. Only eligible candidates according to the regulations of this University shall be admitted to the Allied Health Course.
