AND WHEREAS though the word Christian had been included in the name of the Trust and it had been stated that the proposed Trust was to be a Christian Educational Trust no such restrictions was imposed in the objects and in the body of the Trust.

AND WHEREAS the word "Christian" wrongly conveys the impression that the Trust was to be run on non-secular lines which is not the intention of the FOUNDER TRUSTEE

AND WHEREAS the FOUNDER TRUSTEE is therefore desirous of deleting the word "Christian" wherever it appears in the body of the PRINCIPAL DEED to correct the wrong impression conveyed by the inclusion of such word.

NOW THIS DEED OF RECTIFICATION WITNESSETH AS FOLLOWS:

That in pursuance of above the FOUNDER TRUSTEE hereby rectifies the PRINCIPAL DEED by deleting the word "Christian" specifically from the name of the Trust so that the name of the Trust shall now read as "S.M.R. EDUCATIONAL TRUST" instead of "S.M.R. CHRISTIAN EDUCATIONAL TRUST" and by omitting the said word "Christian" wherever it occurs in the PRINCIPAL DEED except where it appears in the description of the FOUNDER TRUSTEE and the TRUSTEE and that as so deleted, changed and rectified the PRINCIPAL DEED shall remain in full force and effect.
